ON BEHALF OF THE DIVISION OF PLANNING
JANUARY 1, 2024 TO DECEMBER 31, 2024
(\$480,000.00)

WHEREAS, the County submitted an application and was awarded a planning grant from the U.S. Department of Transportation's Safe Streets and Roads For All Grant Program; and

WHEREAS, the funds are in the amount of FOUR HUNDRED EIGHTY THOUSAND DOLLARS AND 00/100 (\$480,000.00) to prepare the "Hudson County Vision Zero Safety Action Plan" which was approved by Resolution No. 482-9-2022; and

WHEREAS, the County issued a Competitive Request for Proposals (RFP) pursuant to N.J.S.A. 40A:11-4.5 to solicit proposals from firms with expertise in the provision of planning studies on behalf of the Division of Planning; and

WHEREAS, the two (2) proposals received as a result of this Request for Proposal were received by the committee utilizing the weighted criteria established and a report has been prepared by the Division of Planning outlining the scoring of the proposal and the recommendation of the evaluation committee; and

WHEREAS, based upon the established weighted criteria, the evaluation committee has recommended the award of this contract to Sam Schwartz Consulting, LLC, 30 Mongomery Street, #1340, Jersey City, New Jersey 07302 in the amount not to exceed FOUR HUNDRED EIGHTY THOUSAND DOLLARS AND 00/100 (\$480,000.00), and funds are available in Account No. 02-213-40-894-23 as certified by the Director of Finance and Administration; and

WHEREAS, N.J.S.A. 40A:11-1(m) provides that competitive contracting can be used for the procurement of consulting services.

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of the County of Hudson, that:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length.
- 2. The Board hereby authorizes the County Executive, Thomas A. DeGise, County Administrator, Abraham Antun, Deputy County Administrator, David B.
